Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi in the case of Shri M. Mallaiah, President, Telangana ST Employees Welfare Association, Hyderabad regarding assault and abuse of ST youth in Suryapet Rural Police Station.

**Date of the Sitting: 26/03/2025, 11:00 AM**  
**Participants in the Sitting: As per Annexure**

President, Telangana ST Employees Welfare Association, Hyderabad, vide representation dated 12-11-2024 has stated that prior to 05-10-2024 for 11 days the Suryapet Rural Police Station authorities of Telangana allegedly subjected Scheduled Tribe youths including Mr. Angadi Janpaiah @ Jangaiah and Mr. Suman etc. to brutal third-degree torture, including physical assault, caste-based abuse, and extreme inhumane treatment such as burning with candle fire on their private parts, on allegations of theft. The petition highlights that such actions violate Article 21 of the Constitution, which guarantees the right to life and personal liberty. The petitioner requests immediate suspension of the responsible police officers, a detailed inquiry by the CBI and judiciary, collection of CCTV footage, registration of FIR under relevant legal provisions and compensation of ₹10 lakhs per victim as per applicable government orders.

2. NCST vide notice dated 24.01.2025 has referred the matter to the DGP, Govt. of Telangana, SP, Suryapet District and SP, Mahabubabad District of Telangana State for facts and comments within 15 days from receipt of the Notice. The reply was not received, hence, NCST decided to discuss the issue with concerned authorities and the petitioner on 26.03.2025. Accordingly, a Sitting Notice was sent on 12.03.2025.

3. In the sitting, the Addl. SP, Suryapet was present on behalf of SP, Suryapet. There was no response from SP, District Mahabubabad and DGP, Govt. of Telangana. The petitioner was also present. In the sitting, officers of Police Department of Suryapet submitted a letter no. 07/C1-NC for STs/ DCRB-SRPT/2025 dated 17.3.2025 of SP, Suryapet alongwith copy of the enquiry report of SDPO, Suryapet in the case. In the enquiry report, it has been mentioned that the complaints the complaints are baseless and the allegations made in it are far from truth. Further, the criminal profile of the affected persons were also provided.

4. After discussion with the Addl. SP, Suryapet and petitioner, the following recommendations were made and action taken report there on may be submitted to NCST within 30 days.

- a. The District SP, Mahabubabad may submit a detailed report on the issue and the rehabilitation efforts of ex-criminals made.
- b. Steps may be taken to ensure that there are no illegal detentions and Human Rights violations on the inmates in custody.
