Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi in the case of Smt E. Nagalaxmi of Mokkalpudi Village, Tekulapalli Mandal, Bhadradi Kothagudem District, Telangana regarding defrauding of ST persons by a youtuber.

**Date of the Sitting: 11/02/2025, 11:20AM**  
**Participants in the Sitting: As per Annexure**

Smt E. Nagalaxmi of Mokkalpudi Village, Tekulapalli Mandal, Bhadradi Kothagudem District, Telangana State, submitted a representation dated 01.07.2024, alleging that Shri Yalamanchili Vijay Kumar of VK Argaspe Media (YouTube Channel) deceived innocent tribals by falsely promising them a sum of ₹10.00 lakhs upon depositing ₹25,000 under the so-called "Nehru Yojana Scheme." As a result, numerous tribals collectively deposited ₹12,50,000. However, upon completion of the tenure, when they inquired about the maturity amount, the accused failed to return their money.

2. NCST vide Notice dated 23.07.2024 has referred the matter to the Director General of Police, Hyderabad, Telangana and the Superintendent of Police, Bhadradi Kothagudem District for seeking facts and comments within 30 days.

3. The Superintendent of Police, Bhadradi Kothagudem District vide reply dated 06.09.2024 stated that he conducted an inquiry into the allegations made by Smt. E. Nagalaxmi against Shri Yalamanchili Vijay Kumar. The investigation, carried out by the SDPO Yellandu, involved summoning the petitioner and other alleged victims who had deposited ₹25,000 each into the purported scheme. Their statements were recorded, and they were asked to provide evidence such as photos, videos, or transaction records to substantiate their claims. However, the petitioner and other complainants failed to submit any valid evidence to establish the alleged offense. Consequently, the Superintendent of Police has requested the Hon'ble Commission to consider the petition as lacking evidence. This was forwarded to the petitioner vide NCST letter dated 15.10.2024.

4 Hence, NCST decided to discuss the issue with the authority and the petitioner on 11.02.2025. Accordingly, a Sitting Notice was sent on 31.01.2025.

5. In the sitting, the Superintendent of Police, District – Bhadradi Kothagudem was present and petitioner joined via phone.

6. After the discussion held in the sitting, the commission recommends the following and the action taken report thereon may be submitted within 30 days from the receipt of the minutes.

a. The call records if any may be taken as evidence and the police may check if there are any other cheating cases booked against Shri Yalamanchali Vijay Kumar or his mediators.

b. Steps may be taken to avoid any such incidences of cheating the innocent tribals.

c. The Project Officer, ITDA may organise awareness programmes about the schemes of government of India and Government of Telangana to avoid any such frivolous promises.


