Back Ground of the Case

A representation dated 21.07.2011 was received from Shri R. Pradas Naik, Convenor, President APCCST Deptt, Hyderabad regarding promotion of Shri B. Redya Naik, Perssonel Officer, Corporate Office, APCPDCL, Hyderabad to the post of Assistant Secretary. The matter was taken up with the CMD, APCPDCL, Hyderabad vide NCST letter dated 23.08.2011.

- 2. The CMD APCPDCL, vide letter dated 27.09.2011 intimated that the case of promotion of Shri B. Redya Naik, for the post of Assistant Secretary will be considered with reference to the Roster point No. 8 as and when he fulfils the requisite conditions for the promotion as per the AP GO MS No. 2 dated 09.01.2004.
- 3. The Convenor, APCCST Deptt. filed a rejoinder dated 08.11.2011 to the Commission. In reply to the rejoinder, the CMD APCPDCL, vide letter dated 04.04.2012 intimated that if Shri Redya Naik, completes 5 years of service in the cadre of Personnel Officer, his case will be considered for promotion as Assistant Secretary.
