Record of Proceedings of the Sitting taken by Shri. Bheru Lal Meena, Member, NCST on dated 03/01/2014 at 11.00AM in the NCST with officers of Delhi Development Authority on the representation of Shri. P.D.Meena, Sr. Architect (North Zone), DDA HUPW regarding reduction of grading in APAR 2011-12.

- The Sitting was chaired by Shri. Bheru Lal Meena, Member, NCST with officers of Delhi Development Authority on the representation of Shri. P.D.Meena, Sr. Architect (North Zone), HUPW, DDA.
- 2. The list of officers who attended the Sitting is attached.
- 3. Member, NCST asked Shri. P.D. Meena to explain his grievance. Shri. P.D. Meena submitted that he is working as Sr. Architect in Delhi Development Authority. His grading in APAR for the period 2011-12 was reduced from Very Good to Good by the Countersigning Officer, Engineer, Member, DDA. He has alleged that his report was not reviewed by Reviewing Officer after Reporting Officer but was directly sent to Countersigning Officer. This has been done to give benefit to the officer Junior to him in the seniority. He has further stated that Reporting Officer had given Very Good in the APAR, even in the previous APARs, his grading was Very Good.
- Shri M.K.Gupta, Commissioner (P), DDA submitted that the petitioner is due to retire on superannuation in February 2014 and at present there is no likely hood of any DPC in near future as there is no vacancy against which Shri. P.D.Meena can be promoted. He further submitted that Reviewing Officer in this case had retired and there was no Reviewing Officer, hence the APAR was sent to Counter Signing Authority for completion. He has further submitted that on an Appeal the petitioner was given a personal hearing by the Vice Chairman, DDA and reasoned order was passed vide order No. 75/Sr.Arch./CC/Pt./3337 dated 17/05/2013. He further stated that the petitioner should have appealed against the order of Vice Chairman, DDA to Lt. Governor of Delhi before approaching the Commission.
- 5. Member, NCST observed that as per the details of APAR 2011-12 the Petitioner has got the following gradings from the Reporting Officer on various aspects:-
