Minutes of the meeting taken by Chairman, NCST held on 12.09.2013 in the Regional office of the Commission at Ranchi regarding alleged harassment of tribals by the officers of the west Bokaro colliery and the previous OIC Mandu, Distt. Ramgarh.

1) S/Shri Suraj Oraon, Satish Oraon, Vijay Oraon, Srawan Oraon, Suresh Oraon and Smt. Madia Oraon W/o late Mahavir Oraon of Vill. Barugutu PO Gato tand Distt. Ramgarh Circle Mandu, Tana no. 118 vide representation dated nil addressed to the Chairperson NCST, New Delhi submitted that they were living in piece of land bearing Khatta no. 48, Plot no 488/3423 along with their family members peacefully. But the Tata Steel is excavating the coal just near their house. They are being harassed and threatened by the Company goons and the Police. The Company is trying to evict them forcefully from their house. The blasting is being done close to their house. The wells and water bodies have been dismantled. Thus company is creating difficulties /hurdles for them to stay peacefully. They have deposited the land rent till 2005, but after that the Block office is refusing to accept the land rent. When enquired it was told that the land is now in the Company's lease hold area.

2) The matter was taken up with Dy. Commissioner as well as with the Supdtt. of Police , Ramgarh vide Commission's letter no MO/1/2013/STGJH/STOTH/RU-3 dated 15.01.2013 and in response to the said letter , Dy. Commissioner vide his letter no. 387 dated 22.05.2013 submitted therewith reports of the (I) Supdtt. of Police, Ramgarh (II) Circle officer, Mandu and (III) Tata Steel, Gato stated that :-

I) Report of the Supdtt. of Police, Ramgarh : It was reported that Mandu (west Bokaro) PS case no 254/09 dated 07.09.09 u/s 3/4 of the Explosive Act and u/s 3(III)/iv/v/x/xi of

SC/ST (PAO) Act, 89 has been lodged and also Civil case Title suit no 78/09 has also been lodged relating to land under reference.

II) **Report of the Circle officer, Mandu:** It was reported that as per Cadastral survey khatian the land in mauza Barugutu PS no. 118, kata no. 48, plot no. 488/3423 is Gairmajurua kas. The land in question does not belong to the applicants and there is no lagan receipt in their name. The excavation work is being carried out by the Tata Steel 100 M away from the said land.

III) **Report of the Tata Steel Gato :** It was reported that the criminal case no. 1289/09 which was filed in the concerned court by Smt. Madia Oraon has been dismissed on 18.05.2011.

3) Hon'ble Chairman, NCST desired to hold a discussion on the above mentioned reports in person at Regional office of the Commission at Ranchi on 12.09.2013. Accordingly the discussions were held on 12.09.2013 in the Regional office of the Commission at Ranchi where Smt. Madia Oraon along with Shri Suraj Oraon and others attended the meeting. The Hon'ble Chairman, NCST asked Shri Suraj Oraon to explain their grievances. Shri Suraj stated that the land in question belongs to them and they have been paying the lagan regularly till 2005 and they are still living on the same place till date. But they are being threatened to leave the place by the goon of the Tata Steel, else consequences will be very bad and the company is trying to evict them forcefully. He has been disengaged from work by the Company. The criminal case no 1289/09 filed in the Court of the Chief Judicial Magistrate, Hazaribagh was settled by compromising with the opposite party by her lawyer without her knowledge. Further, lawyer Shri Sanjiv Kumar Sinha, in connivance with the Company official have taken her thumb impression for compromise but the same has been rejected. Chairperson, NCST asked Shri Suraj to show the original documents in support of his claim of ownership of land , he could not show the original document but submitted a photo copy of the documents.

4) In view of the above position, Chairperson advised the petitioners to meet the Dy. Commissioner, Ramgarh in his office along with the documents in support of their claim and if there is any harassment or threatening by the Company officials they should meet the Supdt. of Police and approach the Commission if need arises. Further, Chairperson also asked the Dy. Commissioner to help them and resolve the matter at the earliest, and send the report to the Commission within one month.
