Record of Proceedings of the Sitting taken by Shri Bheru Lal Meena Hon'ble Member, NCST on 17/04/2013 at 1130 hrs in the NCST with officers of the Ministry of Railways on the representation of Shri R.S. Meena, TTE, Jabalpur, Western Central Railways regarding harassment.

- 1. The Sitting was chaired by Shri Bheru Lal Meena Hon'ble Member, NCST with officers of the Ministry of Railways and Jabalpur, Western Central Railways on the representation of Shri R.S. Meena, TTE, Jabalpur
- 2. The list of officers who attended the Sitting is attached. The petitioner was also present in the Sitting.
- 3. The petitioner Shri R.S. Meena submitted that he is working as Pr. TTE at Jabalpur in Western Central Railways (MP). He is witness in the incident of misbehavior dated 29/12/2011 with Shri Pyar Singh Meena another TTE of Jabalpur Division by officers/staff of Vigilance Department. He is being harassed by CTI(D) Jabalpur of which a complaint dated 03/12/2013 was sent in the Commission. Despite of repeated written complaints to local Railway Administration, no action is being taken against Shri SK Khurana CTI(D) who is harassing him. He is being pressurized by Railway Management through CTI (D) to part with the witness in the case of Shri Pyar Singh Meena. He is being pressurized to help in departmental inquiry by local Railway Management. Railway Management has also lodged a complaint against him in Civil Police. He has stated that his Railway service is in danger and requested for his transfer to Kota Division to the same post and pay scale.
- 4. Shri R.K Mishra, ADRM, Jabalpur submitted that no harassment is being done with Shri R.S. Meena TTE. Consequent to his complaint, he was called several times in the Divisional office to discuss about his grievance. But he told the office that he will not discuss with them till Mr. S.K. Khurana, CTI(D) is transferred. Regarding request of the petitioner for his transfer to Kota Division, the Railway authorities submitted that transfers are done as per rules. Moreover, the petitioner has not applied for his transfer for Kota. If Shri R.S. Meena is transferred to kota Division, he may lose his seniority and the present pay scale. It was also suggested by Railway authorities that transfer of Mr. R.S. Meena can be considered at any station within Jabalpur Division in the same pay scale. But it was not accepted by the Petitioner.
- 5. Shri K.Mal, EDE (Res), Ministry of Railways submitted that transfer of CTI(D) Mr. Khurana is not solution of the problem. However, Railway authorities can consider transfer of Shri R.S. Meena petitioner to any other department at Jabalpur which is not under the supervision of CTI(D) Mr.Khurana. Shri R.S. Meena petitioner agreed and requested for his transfer to any non-cash department at Jabalpur. Shri R.K. Mishra, ADRM, Jabalpur also agreed for transfer of Shri R.S. Meena to any non-cash department at Jabalpur.

6. Hon'ble Member, NCST advised the Railway authorities that Shri R.S. Meena, TTE may not be harassed and he may be transferred to any non-cash department at Jabalpur. Action taken report in the matter be submitted to the Commission within 30 days by the Railway authorities.

7. The Sitting ended with vote of thanks to the Chair.
