Proceedings of the Sitting taken by the Vice-Chairperson, NCST on 23.09.2014 in the case of Shri Balbir Singh, SDE, BSNL, Panchkula (Haryana) regarding harassment.

Date of Sitting: 23.09.2014.

A representation dated 28.02.2014 was received from Shri Balbir Singh, SDE, BSNL, Panchkula (Haryana) to NCST regarding harassment meted out to ST official in BSNL that.

- (1) Denial of promotion to applicant intentionally arbitrarily and knowingly not sending recommendation of applicant for the promotion even ignoring his seniority.
- (2) Blatantly intentionally and knowingly place the applicant under the control of officer junior to him to humiliate the applicant.
- (3) Only the applicant get promotion for 180 days among all promoted officers by the circle office and all other enjoy the promotion for long last and till date.
- (2) The matter was taken up with the CMD, BSNL ON 21.04.2014 for comments. No reply/ report was received from the BSNL Authorities.
- (3) Hon'ble Vice-Chairperson fixed up a sitting on 23.09.2014 to discuss the matter with the chairman cum Managing Director, BSNL.

- (5) The Officers of BSNL informed that promotion given for the higher post at All India Secretary level in 2013.
- (6) The Commission informed the petitioner that the transfer cases of officers/ employees not entertained/ interfere and there was no loss to the petitioner in the matter.
- (7) The Commission asked the BSNL authorities to send the compliance report within 15 days in the matter.
