## NATIONAL COMMISSION FOR SCHEDULED TRIBES

Record of Proceedings of the Sitting taken by Shri Bheru Lal Meena, Member, NCST on 20/08/2013 at 1130 Hrs in the Commission with Additional Superintendent of Police, Alwar (Rajasthan) on the representation of Shri Banwari Lal Meena, R/o Village Tehtada, Tehsil Reini District Alwar regarding atrocity and harassment of his family.

- 1. The Sitting was chaired by Shri Bheru Lal Meena, Member, NCST with Additional Superintendent of Police, Alwar (Rajasthan) on the representation of Shri Banwari Lal Meena, R/o Village Tehtada, Tehsil Reini District Alwar (Rajasthan).
- The list of the officers who attended the Sitting is attached. The petitioner along with his wife and child was also present in the Sitting.
- 3. The petitioner submitted that he is resident of Village Tehtada, Tehsil Reni District Alwar. He belongs to ST community. His neighborers namely Bhagwan Sahae, Devi Sahai, Pooran, Prem Devi, Sunita Devi etc who belong to upper caste have committed atrocity upon his family and harassing them since the last 2 years. There had been a quarrel of his family with the opponents on a small issue two years ago and the issue was resolved. But again Shri Bhawan Sahae and his family attacked on his family. His wife Smt. Guddi Devi and his son Naveen aged 4 years were beaten badly by Shri Bhagwan Sahae and his family His minor son was attacked on the right eye. consequently, his son has become blind due to eye cleave. In this connection a complaint was lodged at Reini Police Station, District Alwar on 01/03/2013 under Section 143/323/341 IPC and Section 3/3(1), 3(X) of SC/ST (POA) Act, 1989 by Shri Banwari Lal Meena. In the beginning, the local police had denied to lodge the FIR on the pretext that they are investigating the case. He further submitted that medical examination of his son was not done and no financial assistance given. His son has become visually handicapped permanently of the right eye. The opposite party is threatening him to face dire consequences and also filed a complaint against him ih Police Station. He was arrested by the Police and prosecuted. But no action was taken by police on his complaint. He also approached the Human Rights Commission and the Commission arranged for police protection (post) for him in the village. But there is no use of the police protection, the opposite party is still harassing him.
- 4. Shri Rajendra Verma, Addl. SP, Alwar submitted that investigation in the matter has been completed. As per investigation report, the children of the opposite party and

petitioner were playing and eye of Naveen S/o Banwari Lal was hit by a ball and was injured on 1/03/2013. However, at that time the petitioner made a compromise with the opposite party before other people of village after taking Rs. 5000/-. However, Shri Banwari Lal is not satisfied with the compromise. He further submitted that a medical examination of Naveen has been got done and report received. An FIR on the complaint of Smt. Guddi Devi W/o Shri Banwari Lal against Shri Bhagwan Sahae, Devi Sahae, Pooran, Prem Devi etc has been filed. Shri Banwari Lal and his family are being given police protection. A police post has been established in the village.

5. Member, NCST observed that it is a clear case of atrocity upon a member of ST. The minor son of Shri Banwari Lal Meena has become blind and disabled permanently due to action of eye cleave by the opposite party. Member, NCST advised the Rajasthan Police to take prompt action on the complaint of Shri Banwari Lal/Smt Guddi Devi and file charge-sheet against the culprits under SC/ST (POA) Act, 1989. Immediate relief may be provided to Naveen, the minor son of Shri Banwari Lal under Rule 12(4) of the Scheduled Castes and the Scheduled Tribes (Prevention of Atrocities) Rules, 1995. The Suprintendent Police, Alwar (Rajasthan) will forward action taken report in the matter within 30 days.

6. The Sitting ended with vote of thanks to the Chair.
