Record of Proceedings of the Meeting with the Secretary & other officers of

Ministry of Development for North East Region (DONER) held on 03/09/2013 at

1200 Hrs in the Commission.

1. To review the achievements under various programmes, polices and problems

of M/o DONER, a meeting with the Secretary & other officers of the Ministry of DONER

was held on 03/09/2013, in the Conference Hall of the National Commission for

Scheduled Tribes, Loknayak Bhawan, New Delhi Ministry of DONER.

2. The Meeting was chaired by the Hon'ble Chairperson of NCST. The list of

participants is annexed.

3. At the outset, Chairperson NCST welcomed the Secretary, Joint Secretaries and

all other officers of the Ministry of DONER and explained the objective of the Meeting.

The Ministry of DONER was requested vide letter No. 28/Review/Service/DONER

/2013/RU-II dated 16/08/2013 to give presentation on implementation of

programmes/schemes, in relation to STs and problems and achievements. Thereafter,

a power point presentation was made by Joint Secretary DONER, Shri Arvind Madhav

on the status of service safeguards and development programmes/schemes for

Scheduled Tribes being implemented by the Ministry of DONER and the PSUs/Statutory

organization under the Ministry (Annexure-A).

4. During presentation, the Joint Secretary, DONER mentioned that two PSUs and

one Statutory organization i.e. North Eastern Handicrafts and Handlooms Development

Corporation Ltd. (NEHHDC), North Eastern Regional Agricultural marketing Corporation

Ltd. (NERAMAC) and North Eastern Council are working under Ministry of DONER. In

order to accelerate the pace of socio-economic development of the NE Region, the

following objectives/goals have been set for the Ministry:-

(i) to facilitate and accelerate project implementation for rapid development in

the region.

(ii) to build capacities and competencies in critical sectors in the NE States.

(iii) to carry out advocacy for facilitating development and understanding the

strategies for development of NER.

(iv) to monitor expenditures of Ministries/Departments of the North Eastern

Region out of their earmaked 10% gross budgetary support (GBS).

(v) to prepare and coordinate strategic plans with line Ministries in E-Sectors for

development of the Region.

5. The main schemes/programmes being implemented are (i) Non-lapsable Central

Pool of Resources (NLCPR), (ii) Advertising and Publicity, (iii) Technical Assistance and

Capacity Building, (iv) Monitoring of Expenditure of 10% GBS, (v) Social Infrastructure

Development Fund (SIDF), and (vi) Externally Aided Project/ADB assisted North

Eastern States Road Investment Programme (NESRIP).

6. Regarding Service safeguards, it was mentioned by the Ministry of DONER that

a Director has been appointed as Liaison Officer for SC/ST/OBCs to ensure proper disposal of grievances, an SC/ST/OBCs Cell is in existence to deal with

disposar of gricvarious, an our objective seems of the se

problems/grievances of SC/ST/OBC members. So far, no incident of harassment of any

ST employee has been reported. In the presentation, it was mentioned that as on

01/04/2013, in Group 'A' posts out of posted 29, 4(39.79%) are ST and in Group 'B'

posts, out of 37, 3(8.1%) are ST. In North-Eastern Council Secretariat as on

01/04/2013, out of total 146 employees in position, 62(42%) are ST. In North Eastern

Regional Agricultural Marketing Corporation Ltd. in Group 'A, 'B' and 'C' posts, out of

total 12 employees in position, 8(66%) are ST and in Group 'D' posts out of total 18

posts, 2(11%) are ST. In North Eastern Handicrafts and Handlooms Development

Corporation Ltd, out of 99 employees in position, in all Groups, 21 are ST.

7. The details of allocation and expenditure of the funds allotted under the Tribal

Sub Plan (TSP) of the Ministry of DONER for the last two years is as under:-

- 8. Chairperson shared the experience of the recent visit of the Commission to Nagaland and Mizoram. Chairperson mentioned that for the development of Scheduled Tribes, a number of steps were needed to be taken and, in particular, emphasized on the following areas;
 - (i) At present, there is no Medical College and Nursing College in Kohima. Thus, there was a need for setting up of a Medical Colleges and Nursing Colleges in Kohima and also in other parts of the North-East Region.
 - (ii) State Government officials of Nagaland had indicated that during annual festivals organized in Kohima, there is inadequacy of Hotels / Guest Houses and other related infrastructure to accommodate the tourists. To create a regular source of income generation, action for investment in tourism industry needs to be taken.
 - (iii) investment in agriculture sector was required to improve the farming activities.
 - (iv) Linkages of Marketing of MFP and Agriculture Produce was needed so that better price mechanism prevails and perishable items do not cause loss to the farmers in the absence of proper linkages.
 - 10. The secretary, M/o DONER informed that steps on the above areas were being taken and Tata Consultancy Services was assigned the task of preparing Master Plan and necessary measures were being taken for the overall development of the NER.
