Sub: Representation from Shri Rajendra Oraon, Draughtsman Gr.I(C), Dte, Of Naval Design (SSG), New Delhi-48 regarding discrepancies in promotion.

for the grade of Chief Draughtsman (C) in Navy.

Sir,

I am directed to refer to the discussion held in the Commission dated 30.09.2009 on the above subject with the officers of MoD (Navy). The Proceedings of the discussion were sent to the MoD (Navy) for compliance vide Commission's letter No. RU-IV/service/Defence-19/2007 dated 03.11.2009 (copy enclosed). In compliance to the discussion, there was protracted correspondence and vide letter no. CP(G)/2621/CDM/(Const) dated 18.10.2010, Director/CP(G), MoD (Navy) informed to NCST that 'the proposal for creation of two Supernumerary posts of CDM (Const) in the prerevised pay scale of Rs.6500-10,500 w.e.f 27 July 2007 to accommodate two ST candidates has been taken up with the MoD. The proposal has been considered by the DOP&T who have forwarded the case to Min. of Finance, Deptt of Expediture on 14 Sep 2010. All out efforts are being made to obtain app. If of the Min. of Finance for creation of Supernumerary posts at an early date soft at DPC can be held for considering promotion of Shri Rajendra Oraon to the post of CDM(Const). Further progress on the action taken shall be intimated on receipt of the decision of Min. of Finance'.

The MoD (Navy) further informed vide their letter no. CP(G)/2621/CDM/(Const) dated 17.08.2011 that 'the proposal for creation of two supernumerary posts of CDM(Const) in the pre-revised pay scale Rs. 6500-10.500 revised to Rs.9300-34800 with Grade Pay Rs.4600 sent to Min. of Finance through MoD(Fin/Navy) has not been agreed to vide their Note No.A-11019/12/2010-EG dated 26.04.2011. However the case has again been taken up with Min of Finance vide this HQs Note dated 26 April 2011. Further progress shall be intimated on receipt of the decision of Min. of Finance.
