## **National Commission for Scheduled Tribes**

Brief of the case of forcible encroachment on a house owned by Smt. Radha Rani W/o Shri Babu Ram Meena, R/o RZ-71-72, Jain Colony Part-II, Shani Bazar Road, Uttam Nagar, New Delhi-59 and harassment by a political influential family of a Non-ST with a ST family, Deputy Commissioner Police, South-West Delhi called for hearing of before Hon'ble Chairman, National Commission for Scheduled Tribes scheduled on 22/05/2013 at 15:30 Hrs.

A complaint dated 12/12/2012 was received in the Commission from Smt. Radha Rani W/o Shri Babu Ram Meena, R/o RZ-71-72, Jain Colony Part-II, Shani Bazar Road, Uttam Nagar, New Delhi-59 stating that the above mentioned house was purchased from Shri Sukhbir Singh Tyagi S/o Shri Atar Singh Tyagi, After a gap of some time, Shri Adesh Tyagi S/o Shri Mahesh Chand Tyagi, R/o RZ-3, Jain Colony, Part-III, Shani Bazar Road met her with a request to give upper portion of her house to him because his house was under construction. On his request, Smt. Radha Rani allowed him to live in the upper portion of her house considering his request on humanitarian ground. After completion of the construction of his house she asked him to vacate her house but he denied entirely to vacate her house.

Smt. Radha Rani further mentioned that on 21/09/2012 on Shri Adesh Tyagi alongwith his other family members attacked brutally on her family members and beaten us and torn my clothes for outraging her modesty. She called the PCR van on phone No. 100 but police did not turn on the spot. Consequently, she went to the PS, Bindapur for lodging a complaint but police

did not lodge her complaint. Thereafter, Sub-Inspector called her on the Police Station at about 8:00 PM and they were sent for medical examination at Deen Dayal Hospital at 9:00 PM. The medical examinations were executed at Deen Dayal Hospital and they returned at about 2:00 AM. It is alleged that the Tyagi family tortured physically and threatened for the dire consequences and also used derogatory remarks with a caste consideration.

Considering the seriousness of this case, the Commission had taken up the matter with the Police Commissioner of Delhi calling for full facts of this case alongwith details of action taken in the matter, vide Commission's letter dated 12/10/2012. In this context, the Additional Deputy Commissioner of Police, South West District, New Delhi vide his letter dated 10/12/2012 replied the Commission that the material available on record indicates the offence of trespass, causing hurt, outrage of modesty and threatening. Accordingly a case FIR No. 353/12 u/s 451/323/354/506/34 IPC was registered at PS Bindapur on 01/11/2012 and investigation is being taken up.

A copy of the report received in the Commission was forwarded to the petitioner (Smt. Radha Rani). Commenting on the enquiry report received from the Delhi Police, Smt. Radha Rani W/o Shri Babu Ram Meena submitted three rejoinders dated nil (received in the Commission on 06/03/2013, 08/03/2013 and 18/03/2013 respectively) repeating the allegations alleged as earlier in the complaint.

Commissioner of Police, South-West District vide Commission's letter dated

01/04/2013 for offering comments. Three reminders have been issued on 22/04/2013, 03/05/2013, 10/05/2013 respectively but no reply has been received from the Delhi Police so far.

In view of above a Sitting in this case has been scheduled by the Chairperson on 22/05/2013 at 11:30 Hrs in his Chamber with Deputy Commissioner of Police, South West District, Sector-19, Dwarka.
