The National Commission for Scheduled Tribes set up under Article 338 A of the Constitution is vested upon with duties inter-allia, to investigate and monitor all matters relating to the safeguards provided to the Scheduled Tribes under the Constitution or under any other law for the time being in force or under any order of the Government and to monitor and evaluate the working of such safeguards.

Ministry of Corporate Affairs, vide Gazette Notification no. 95 dated 27/02/2014 on CSR and DPE guidelines dated 21/10/2014, has issued direction to all CPSUs to start new welfare scheme for weaker section under CSR. In the revised guidelines, the thrust of CSR and Sustainability is clearly on capacity building, empowerment of communities, inclusive socio-economic growth, environment protection, promotion of green and energy efficient technologies,

development of backward regions, and upliftment of the marginalized and under-privileged sections of the society making it mandatory in the revised guidelines for CPSEs to take up at least one major project for development of a backward district has the potential of contributing significantly in the long run to socio-economic growth in all the backward regions of the country.

- 3. Accordingly, the National Commission for Scheduled Tribes has decided to review and assess the implementation of corporate social responsibility fund and activity under the CSR. You are requested to furnish information sought in the Performa enclosed. A soft copy of the same may also be provided. The information provided shall facilitate the Commission to review and asses implementation of CSR in your organization.
