The Principal Secretary, Health Department Govt. of Jharkhand did not attend the meeting. The Commission views seriously the no-attendance of Principal Secretary, Health Department without any intimation. If he had any problem, he should have informed the Commission and authorised a Competent Officer to represent the department.

Shri B.C. Jha, Joint. Secretary, Finance Department, Govt. of Jharkhand attended the scheduled meeting on behalf of the Principal Secretary, Finance Department. Shri Jha stated that the consent of the Finance Department has already been given in the file of the Health Department for implementation of Pay scale w.e.f. 01-01-1996, as approved vide Resoluation No. 20491/F dated 23.09.2011, for grant of financial benefit w.e.f. 15.11.2000 in respect of need based identified posts of non-teaching medical officers of Jharkhand Health services. He further stated that the required issuance of memorandum for amendment in clause 2049 dated 23.09.2011 is under process. It is likely that the same would be put up shortly before the Cabinet, Government of Jharkhand.

In view of the above, Principal Secretary, Health Department and Principal Secretary, Finance Department, Government of Jharkhand are advised to apprise the status of the progress in the matter to the National Commission for Scheduled Tribes latest by 15/02/2015.
