Proceedings of the Sitting taken by Shri Ravi Thakur, Hon'ble Vice-Chairperson, NCST on 11.08.2014 in the matter of Dr. D. Koteswara Rao, Professor of Civil Engineering, J.N.T.U.K., Kakinada (AP) regarding harassment and promotion.

Pursuance of the Proceedings of Sitting held on 26.02.2014, another Sitting was fixed on 11.08.2014 by the Hon'ble Vice-Chairperson, NCST.

- The Vice Chancellor, J.N.T.U.K appeared before the Commission and stated that 2 the Commission had advised "to see that ST Professor should not be harassed in the university and also suggested that the case shall be closed from the date of its implementation and the entry of the case in service Record shall be deleted. Dr. D.K. Rao shall be considered for getting promotion and responsibilities in the University".
- On discussion, the Commission noted that the case of Dr. Koteswara Rao has not been placed the facts not properly analysed by the Vice Chancellor and placed before the MDC. The Proceedings was placed before the MDC in the meeting has further discussed as per the resolution of XXVth MDC of JNTUK that "after examining the suggestions made by National Commission for Scheduled Tribes (NCST). Government of India, New Delhi and since there is no new changes happened in the CBI and Single Judge Commission's report on Dr. D. Koteswara Rao, from the earlier MDC meetings, and hence resolved that there is no change in the earlier decision taken by MDC".
- The petitioner was also present and explained his grievances.
