Sub: Minutes of the Sitting in the case of D.V. Deoghare, an employee of the Central Railway held under the Chairmanship of Hon'ble Vice Chairperson in the National Commission for Scheduled Tribes.

- 1. Sitting was held under the Chairmanship of Hon'ble Vice Chairperson, National Commission for Scheduled Tribes to discuss the case of Shri D.V. Deoghare, Sr. DPO/Pune, Central Railways in the Conference Room, National Commission for Scheduled Tribes at 4:30 PM on 29/04/2015.
- 2. The list of participants in the Sitting is given at Annexure A.
- 3. Initializing the discussion, the petitioner, Shri D.V. Deoghare expressed his grievance that in the selection held for the promotion to the post of APO (Group B) in 1992-93, he qualified the written test and was called for viva-voce. Thereafter, the Central Railway Administration issued the integrated seniority list of qualified candidates separately for UR, SC & ST candidates which is in violation of the Policy of the Railways. The seniority list should have been drawn based on the length of service in a particular grade. He further stated that another ST candidate namely Smt. S.V. Chordekar who was empanelled against the ST vacancy should have been adjusted against UR vacancy because she qualified the selection with general standards and the resulting ST vacancy should have been filled by the next candidate in the select list. This would have made him eligible for the promotion.
- 4. Officers from the Railways (the Railway Board and the Central Railway) stated that the concept of own merit in promotion was introduced w.e.f. 07/08/2002. Before this, the concept of "own merit" was applicable only in direct recruitments. Since the said selection was made in 1992-93, "own merit concept" is not applicable in the case of Shri D.V. Deoghare. Hence the argument of considering Smt. S.V. Chordekar against UR point is not tenable. They have clarified that in promotion to posts classified as selection posts, those SC/ST candidates who qualify with general standards should be empanelled first and only the deficiency in the reserved quota should be made good by those SC/ST candidates qualified with relaxed standards. Officers from the Railways stated that after declaring the result of that selection procedure, all the candidates were given time for their filing representation, if any. Only after examining all such representations, the final seniority list was published. They also stated that the selection took place more than 21 years ago and therefore the case has now become time barred. All the records pertaining to the selection have since been destroyed as per their policy on Record Retention Schedule.
- 5. After hearing both the parties, the Hon'ble Vice Chairperson, NCST advised the Railways to again review the case of Shri D.V. Deoghare who belongs to ST community sympathetically and action taken may be intimated to the Commission.
- 6. The Sitting ended with vote of thanks to the Chair.
