Proceedings of the Sitting taken by Shri Ravi Thakur, Hon'ble Vice-Chairperson, National Commission for Scheduled Tribes in the matter of Shri Mukesh Kumar Meena, Dy. CTI, Saharanpur regarding alleged harassment and cancellation of transfer from Ambala Division to Moradabad Division.

- 1. The petitioner, Shri Mukesh Kumar Meena, Dy. Chief Ticket Inspector, working in Northern Railway, Saharanpur represented to NCST on 06/03/2014 alleging that he has been charge sheeted and a vigilance case has been instituted against him.
- 2. The NCST vide letter dated 07/03/2014 and 14/03/2014 sought comments from Ministry of Railways and Sitting was fixed on 03/04/2014 in the matter. The Ministry of Railway vide letters dated 26/03/2014 and 02/04/2014 furnished comments/factional position of the case that a preventive check was conducted by a team of NR vigilance in train No. 18104 on 28/08/2013 between JUC-LDH. During the check Shri Meena, Dy. CIT/SRE was found in coach No. A-1 in proper uniform. He was asked to produce EFT book for vigilance check and EFT No. 083292 was closed for vigilance check. Shri Meena did not cooperate with the vigilance team and the check hence could not be completed. Also his allegation of demanding Rs. 50000/- as bribe and caste based atrocity is false and fabricated. As Shri Meena had non-cooperated with the vigilance team it was recommended to issue major penalty alongwith transfer out of division. The decision to transfer Shri Meena to Moradabad was taken by CCM/PS. The vigilance department never recommends the division/place of transfer.
- 3. Northern Railway vigilance conducts extensive preventive checks to curb corruption/malpractices in the mass contact areas, so as to increase the satisfaction level of the passengers. preventive checks conducted are on the staff irrespective caste/community/religion/region or gender basis and disciplinary action against the defaulting staff is taken according to the set principles, guidelines and practices in voque without any discrimination, keeping in view the gravity of the irregularity. The allegations leveled by Shri Meena are reported to be baseless and have been leveled to dilute the vigilance investigation and departmental proceedings against him.
- 4. As scheduled a Sitting was held on 07/08/2014. The Commission informed the officials of Railways that Commission does not intered in the matter of vigilance as well as transfer cases.
- 5. The Deputy CCM/G informed that Railway Union/Assosication has written to Railways to consider the case transfer of Shri Meena to Delhi, since his wife is a heart patient. The Dy.CCM(G) informed that Railways is considering the case of Shri Meena for transfer to Delhi on extreme medical grounds.
