Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi in the case of Shri Dugyala Ramesh S/o Saraiah, Post/Mandal-Atmakur, District - Hanumakonda, Telangana regarding non grant of e-pattadar passbook despite long possession.

Shri Dugyala Ramesh, vide his representation dated 07.06.2024, has alleged that he belonging to the Scheduled Tribe Yerukala Community and residing in Atmakur, Hanamkonda District, Telangana, has been cultivating agricultural land in Sy.No.97/1/13 and Sy.No.97/1/14, totaling 0.20 guntas, for the past 20 years and has also constructed four rooms on the said land. Despite applying for an E-Pattadar Passbook since 2012 to avail government benefits under schemes like Rythu Bandhu and Rythu Bheema, the Tahsildar has refused to issue the same, causing him undue hardship. Further, he alleges that revenue officials, in collusion with the police, demolished his constructed rooms, threatened him to vacate the land, and harassed him due to his Scheduled Tribe status. He contends that such actions amount to discrimination and attract penal provisions under the Scheduled Castes and Scheduled Tribes (Prevention of Atrocities) Act, 1989. He seeks immediate intervention and necessary action against the concerned revenue and police officials to ensure the issuance of the E-Pattadar Passbook.

2. NCST vide Notice dated 09.08.2024 has referred the matter to the District Collector, Hanumakonda for seeking facts and comments within 15 days.

3. The District Collector, Hanumakonda, in response to the petition of Shri Dugyala Ramesh, has stated vide letter dated 09.09.2024 that as per the 2012 revenue records, the petitioner is recorded as an occupant of the land in Sy.No.97/1/13 and 97/1/14, while one Shri Thanugula Ramanujam is the registered Pattadar. A field enquiry confirmed that Shri Ramesh is in possession of 0.20 guntas of land, with 0.03 guntas used for pig breeding and the remaining kept fallow. It was found that he had purchased the land from Shri Thanugula Ramanujam through an unregistered sale deed on a ₹100 stamp paper. However, the Tahsildar denied his request for a Pattadar Passbook since the land in question is Government Assigned Land, and under the Telangana Assigned Lands (Prohibition of Transfer) Act, 1977, such lands cannot be transferred or regularized in favor of third parties. Additionally, the land falls within a 5 km radius of the Athmakur Mandal headquarters, further restricting its transferability.

4. NCST decided to discuss the issue with the authority and the petitioner on 11.02.2025. Accordingly, a Sitting Notice was sent on 31.01.2025.

5. The Collector & District Magistrate vide letter dated 4.2.2025 has furnished the facts and again enclosed their letter dated 09.09.2024.

6. In the sitting, the Revenue Divisional officer (RDO), Hanumakonda District was present on behalf of District Collector, District – Hanumakonda. The RDO, Hanumakonda District has reiterated the facts submitted by District Collector vide letter dated 4.2.2025. The authority has informed that the Assigned land are prohibited from transfer and further the land falls in the radius of 5 Km from Municipal limits of the town. Hence registrations could not be made.

7. The petitioner was also present. The petitioner informed that there are some other cases where the land has been allotted to the third party in the survey No.100. He had already lost his land when it was encroached for making a path to the burial ground requested to do justice for registering and providing the land records on his name.

8. After discussion with the Revenue Divisional Officer, Hanumakonda District and petitioner, the following recommendations were made and action taken report there on may be submitted within 30 days.

- a. The Deatails of the lands assigned priorto 2014 and after 2014 may be provided.
- b. The Revenue authorities may clarify asto why there is a problem to issue RoR on the name of the petitioner if the assignees from other communities are issued the same in the same village in the same survey number.
