

Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi in the case of B. Suresh, District Khammam (Telangana), Khammam, Telangana regarding alleged illegal land transfer.

Date of the Sitting: 11/02/2025, 02:00 PM

Shri Boinapalli Suresh vide representation dated 12.07.2024 alleged about the encroachment of 10 acres of government-allotted land, originally granted to his grandfather, Boinapalli Pullaiah, a recognized freedom fighter, under G.O. M.S No. 846/79. Despite multiple appeals by his grandfather and father to government officials for proper title issuance, the land was reportedly transferred illegally to private individuals—Ravi Basaveswara Rao and Ravi Venkata Suresh Babu—through fraudulent means, including falsified documents and passbooks. The petitioner asserts that their family has been deprived of their rightful inheritance due to the influence of powerful individuals, leading to distress and financial loss. He seeks intervention from NCST to investigate the matter and facilitate the rightful transfer of the land to his family.

2. NCST vide notice dated 09.08.2024 to the DM and Collector, Bhadradi Kothagudem vide NCST letter dated 09.08.2024 for seeking facts and comments within 15 days. The reply was not received from the concerned authority. Hence, NCST decided to discuss the issue with the authority and the petitioner on 11.02.2025. Accordingly, a Sitting Notice was sent on 31.01.2025.

3. The Collector & District Magistrate, District – Bhadradi Kothagudem vide letter dated 5.2.2025 has submitted the facts and comments and stated that in this matter an enquiry was conducted by the Tahsildar, Aswaraopeta and found that the petitioner's family never cultivated the land, and the claim is being raised 32 years after the sale.

4. In the sitting, the Collector & District Magistrate, District – Bhadradi Kothagudem was present. The petitioner joined the sitting via Video Conference. In the sitting it was found that the petitioner belongs to Non ST Community.

5. After discussion with Collector & District Magistrate, District – Bhadradi Kothagudem and petitioner, it was observed that no further action required on the part of NCST in the present case. Hence the case may be closed.
