Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi in the case of Chintha Jogaiah and Chintha Bhadramma regarding alleged illegal transfer of their ancestral land.

The Chintha Jogaiah and Chintha Bhadramma, belonging to the Scheduled Tribe, vide petition sent on 27.02.2024 seek redress before the NCST regarding an alleged illegal transfer of their ancestral land (21 acres in Sy.No.303/12/1, Gangaram village, Tekulapalli mandal, Bhadradi-Kothagudem district) to a non-tribal, Ravella Venkatarama Rao, in violation of the Andhra Pradesh Scheduled Areas Land Transfer Regulation, 1959 (amended in 1970). Despite holding pattadar passbooks and title deeds, the petitioners were falsely accused of trespassing in 2013, leading to legal proceedings, which ultimately resulted in their acquittal. The petition highlights administrative misconduct by revenue authorities, including the wrongful cancellation of the petitioners' land records, unauthorized mutation in favor of the non-tribal respondent, and failure to enforce protective tribal land laws. The petitioners seek action against the non-tribal respondent and disciplinary measures against the responsible officials, along with the restoration of their land as per the agency regulations.

2. NCST vide Notice dated 30.05.2024 had referred the matter to Collector and DM, Bhadradi Kothagudem, Telangana for seeking facts and comments within 30 days. The reply was not received from the concerned authority. Hence, NCST decided to discuss the issue with the authority and the petitioner on 11.02.2025. Accordingly, a Sitting Notice was sent on 31.01.2025.

3. The Collector & District Magistrate, District – Bhadradi Kothagudem vide letter dated 08.02.2025 has furnished the facts and stated that the subject land issue is pending at the Hon'ble High Court of Telangana in W.P No. 16406/2016 till today and requested to close the case.

4. In the sitting, the Collector & District Magistrate, District – Bhadradi Kothagudem was present and petitioner joined via Phone.

5. After the discussion with the Collector & District Magistrate, District – Bhadradi and petitioner, it was observed that the action on part of NCST is not required, as the matter is subjudice with the Hon'ble High Court of Telangana.
