Sub: Press clipping of News Report the Times of India dated 01.10.2013 regarding captioned "Savagely rescued maid from VK flat".

Sir,

I am directed to refer to this Commission's letter of even number dated 01.10.2013 and subsequent letter dated 04.10.2013 on the above subject and to say that Commission has noticed that the incidents regarding large level of migration of STs particularly females to metropolitan cities and their reported exploitation by the middlemen/placement agencies, which have hitherto been unregulated, have been

brought to the Commission in past also. The Commission also recalled that a case regarding alleged exploitation and sexual harassment of a ST girl while accompanying/staying with an official posted on a foreign assignment was also brought to its notice in the past.

As large number of cases of exploitation of Tribals, migrated from Scheduled Areas and Tribal areas and engaged as domestic workers has come to limelight through media and also through representations to this Commission and also through various Parliament Questions. The Commission has observed that an actionable policy for safeguards of tribals engaged as domestic workers needs to be formulated urgently to prevent exploitation by employers as well as by the placement agencies.

In view of above, Dr. Rameshwar Oraon, Chairperson, NCST has desired to discuss the issue with you in person on 10<sup>th</sup> October, 2013 at 11.30 hrs at Conference Hall, 6<sup>th</sup> Floor, Lok Nayak Bhawan, New Delhi. I am, therefore, request you to kindly make it convenient to attend the aforesaid meeting at the scheduled date/time.
