



Applications are invited for filling up of one post of Office Superintendent, Group 'B' Non-gazetted, Level 6 (Rs. 35400-112400) of the 7th CPC Pay Matrix, on deputation basis, in the National Commission for Scheduled Tribes. The post is located at the Regional Office of NCST, Shillong.

2. Job requirements, experience and qualifications required for the post are as under:

Officers of the Central Government, State Governments, Union territories, autonomous or statutory organisations, public sector undertakings, Universities or recognised research institutions, -

(a) (i) holding analogous post on regular basis in the parent cadre or department; or

(ii) with six years' service in the grade rendered after appointment thereto on a regular basis in the posts in level-5(Rs29200-92300) in the pay matrix or equivalent in the parent cadre or department; or

(iii) with ten years' service in the grade rendered after appointment thereto on a regular basis in the posts in level-4 (Rs.25500-81100) in the pay matrix or equivalent in the parent cadre or department; and

(b) Possessing the following educational qualification and experience:

(i) Bachelor Degree from a recognised university or institute, and

(ii) having two years' experience in administration or establishment or accounts matters.

Note 1: The departmental officers in the feeder category who are in direct line for promotion shall not be eligible for consideration for appointment on deputation.


Note 2: The period of deputation including the period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization or department of the Central Government shall ordinarily not to exceed three years. The maximum age limit for appointment by deputation shall not be exceeding fifty-six years as on the last date of receipt of applications.
