## E. DISHA

Programme DISHA launched in July, 2016, is an effort to improve development coordination and monitoring within the Constitutional framework of responsibilities assigned to Central, State and Local Governments. DISHA wil cover all non-statutory schemes of Government of India that are administered in general. As per guidelines for the programme, district level Coordination and Monitoring Committees has to be set up in each district with Senior most MP (Lok Sabha) elected from the District as Chairperson, and Members of State Legislative Assembly elected from the district and other people's representatives etc. as members and the District Collector as the member-Secretary. Further, the meetings of the committee should be held once in every Quarter (Third Saturdays of April, July, October and February). The committee has to ensure that all programmes are implemented in accordance with the Guidelines and look into complaints/alleged irregularities received in respect of the implementation of the programmes, including complaints of wrong selection of beneficiaries, mis-appropriation / diversion of funds and recommend follow-up action. The Committee has also to closely review the flow of funds including the funds allocated, funds released by both Centre and the State, utilization and unspent balances under each Scheme.
