Sub: Review of constitutional safeguards for Scheduled Tribes in Ranchi Municipal Corporation-reg.

Sir,

The National Commission for Scheduled Tribes (NCST) has been set up under Article 338A of the Constitution of India vested with responsibility *inter-alia* to investigate and monitor all matters relating to the safeguards provided to the Scheduled Tribes under the Constitution or under any other law for the time being in force or under any order of the Government and to monitor and evaluate the working of such safeguards. The NCST is required to present to the Hon'ble President of India, annually and at such other times as the Commission may deem fit, reports upon the working of those safeguards.

2. Accordingly, the NCST has decided to review the implementation of constitutional safeguards including welfare measures and reservation policy in respect of Ranchi Municipal Corporation, (Ranchi Nagar Nigam), **tentatively from 25th July 2026 to 30th July 2026.**

3. The NCST has compiled a questionnaire for review, a copy of the same, is enclosed, for furnishing replies / information by Ranchi Municipal Corporation. The replies to various issues covered under the questionnaire will form the basis for review meeting. A soft copy of the replies to the questionnaire may also be sent to ru4-hq@ncst.nic.in and sonal.raj@gov.in for record.

4. A brief presentation along with measures / programmes taken up by Ranchi Municipal Corporation for welfare of Scheduled Tribes in the country may also be made during the review meeting before the Commission. Additionally, arrangements for backdrops, photography, and videography may also be made for the meeting.

5. It has also been decided that the Commission will discuss the issue of grievances of Scheduled Tribes community leaders before the Review Meeting. The association leaders from ST community along-with ST employees may be asked to attend the Meeting. The Liaison Officers for STs in the Department may also be asked to attend the Meeting.
